AGREEMENT
INDEMNITY; RELEASE OF LIABILITY;
WAIVER; AND, COVENANT NOT TO SUE.

I, the undersigned, do for him/herself, his/her heirs, executors, administrators and assigns, acknowledge and agree that in consideration for permission to participate in the Activities (defined below), I shall indemnify, hold harmless and defend, and release from all liability, and covenant not to sue, the Brujos Masters Charities, including its affiliated clubs, officers, directors, employees, administrators, representatives, volunteers, agents, participants, predecessors successors and assigns (collectively "Releasees"), for any injury, illness, death, loss or damage to person or property that I may suffer in connection with any Activities in which I may engage by access through any program, facility, and/or service provided by or through the Releasees, including, without limitation, activities such as administrative support, transportation, lodging, meals, entertainment, recreation including competitive and/or non-competitive soccer or other athletic activity, and any other programs or services (collectively the "Activities") whether arising from the negligence of Releasees, or otherwise, to the fullest extent permitted by law.

I further acknowledge that: I have the requisite skills, qualifications, physical abilities, and training necessary for proper and safe participation in the Activities; I am not suffering from any condition, impairment, or illness that would prevent me from participating in the Activities; I have been informed of the recommendation for a physician's approval to participate in the Activities and have either obtained a physician's approval or have decided to participate without obtaining such approval; and, I hereby assume all risks that arise out of the Activities, including, but not limited to, risk of financial loss, property damage, bodily injury, and possible death.

I acknowledge and agree that this Agreement applies to all claims for any injury, illness, death, loss or damages that I may suffer, financial or otherwise, whether known or unknown, or foreseen or unforeseen, that arise out of the Activities. I am aware of the provisions of California Civil Code section 1542 which states:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor."

I hereby waive the provision of California Civil Code section 1542. I agree that I, my spouse, domestic partner, partner, assignees, heirs, guardians, and legal representatives will not make any claim against, sue or attach the property of Releasees, or any of them, for any loss or damage resulting from my participation in the Activities.

WARNING! THERE ARE OBVIOUS KNOWN DAMAGERS INHERENT IN THE ACTIVITIES. FOR EXAMPLE, THE RISK OF: FINANCIAL LOSS; ILLNESS; SEVERE BODILY INJURY; AND/OR DEATH.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS AN INDEMNITY, A RELEASE OF LIABILITY, A WAIVER OF MY LEGAL RIGHT TO COLLECT DAMAGES IN THE EVENT OF FINANCIAL LOSS, PROPERTY DAMAGE, ILLNESS, INJURY, OR DEATH, AS WELL AS A COVENANT NOT TO SUE, IS A CONTRACT WITH RELEASEES, AND SIGN IT OF MY OWN FREE WILL.
